ORDER

No. EDUB-E05/9/2023

Dated: Shimla-2, the 30-11-2023.

Whereas Sh. Narotam Ram, Principal, approached the Hon'ble High Court vide CWP No. 6909 of 2023 seeking his transfer on ground that he has already served in Hard/Tribal area and has been once again posted in Hard/Difficult area and on the grounds of adverse family circumstances. The Hon'ble High Court decided the matter on 17.10.2023 and the operational part of the judgement is as under:-


"In view of above, present petition is disposed of with a direction to respondent No. 2 to decide the pending representation of the petitioner i.e. Annexure P-2 in terms of Comprehensive Guiding Principles/transfer policy, wherein admittedly provision has been made to offer a station of choice to an employee, who has already served in hard area for normal tenure, expeditiously preferably within a period of two weeks. Needless to say, authority concerned, while doing the needful in terms of this order, shall afford an opportunity of hearing to the petitioner and pass speaking order thereafter. Liberty is reserved to the petitioner to file appropriate proceedings, before appropriate court of law, if he still remains aggrieved."

2. Whereas, as per the directions of Hon'ble High Court and the petitioner was afforded an opportunity of being heard in person on 17.11.2023. During the hearing the petitioner submitted that he has already served in Hard/Tribal area and now he is once again posted in a Difficult area and also submitted that there is no one to look after his mother who is 82 years old and suffering from many diseases.
3. Whereas, from the perusal of records it has been admittedly found that he has earlier served in Distt. Kinnaur and now he is posted at GSSS Kharga, Distt. Kullu which is a difficult area.

4. Now therefore, the undersigned after careful consideration of all the facts and circumstances of the case decided to post Sh. Narotam Ram, Principal, GSSS Kharga, Distt. Kullu at GSSS Jai Devi, Distt. Mandi against vacancy being caused after 30.11.2023 due to transfer of present incumbent. Accordingly the matter is disposed off.


