The Principal GSSSs:- Khushnagri, (CBA)/ Jalag, (KGR)/ Minjgran, (KGR) with the direction that incumbent working under your establishment be relieved immediately failing which disciplinar action will be initiated against the defaulter under the rules and also be ensured that there is a court case—before relieving /joining the above said officials.
