

**Order**

In partial modification of this Department's Order of even number dated the 24<sup>th</sup> November, 2020, it is hereby ordered in the public interest that:-

- (i) Government servants of all classes (Class-I to Class-IV) and categories of posts, including those working on contractual, daily wages, part-time and outsourcing basis will attend office on all working days except on Saturdays.
- (ii) All employees/ officers will work from home on all working Saturdays.
- (iii) Besides, the employees, who are Persons with Disabilities (*Divyangjan*) and require assistance of other person(s) to reach the workplace, shall continue to be exempted from attending office till 31<sup>st</sup> December, 2020.
- (iv) Other conditions stipulated in the earlier orders ibid will remain operative.


This Order shall remain in force w.e.f. 1<sup>st</sup> December, 2020 to 31<sup>st</sup> December, 2020.
