

Notification

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh is pleased to make the following rules further to amend the Fundamental Rules, in their application to the State of Himachal Pradesh, namely:-

Short title and commencement:- 1. (1) These rules may be called Fundamental (in their application to the State of Himachal Pradesh) First Amendment, Rules, 2018.

(2) These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

Amendment of rule-56.

2. In rule-56 of the Fundamental Rules, after the second proviso to clause (e), the following third proviso shall be inserted, namely:-

"Provided further that a Class-IV Government servant appointed on part-time/ daily wages basis prior to 10-05-2001 and regularized on or after 10-05-2001 shall retire from service on the afternoon of the last day of the month in which he attains the age of 60 years."


