ORDER

Whereas, petitioners are working in the Elementary Education Department as language teacher and Shastri which comes under C&V category. As per existing R&P Rules of TGT cadre C&V category is feeding post of the Cadre. The nomenclature of these petitioners as TGT have been notified on 20.08.2022 in own pay scale, however their right are intact in C&V category. They have filed CWP No. 3455/2023 titled as Nita Rani & Ors. versus State of HP & Ors., CWP No. 8389/23 titled as Chinta Devi & Ors. vs State of HP & Ors., CWP No. 8390/23 titled as Yashunandni Katoch vs State, CWP No. 3453/2023 titled as Vinita Devi & ors. vs State of HP & ors., CWP No. 3454/2023 titled as Karuna Mehta & ors. vs State of HP & ors., CWP No. 3456/2023 titles as Uma Devi & ors. vs State of HP & ors., CWP No. 3457/2023 titled as Meera Devi & ors. vs State of HP & ors., CWP No. 3458/2023 titled as Kiran Bala & ans. Vs State of HP & ors. & CWP No. 3459/2023 titled as Anuradha & ors vs State of HP & ors. which has been disposed of on 12.06.2023 is as under:-

“Learned counsel for the petitioners states that the issue in question is squarely covered by the judgment dated 13.01.2012 rendered by the learned Division Bench of this Court in LPA No. 102/2010, titled as Dr. Lekh Raj Sharma & ors. vs State of HP & anr., which, in turn, has been followed by the learned single judge of this Court in CWPOA No. 863/2019, titled as Ashok Kumar Sharma & anr. Vs. State of HP & ors. decided on 16.07.2020. This is a matter, which is required to be examined and considered by the respondent-State.

Accordingly, without going into the merits of these cases, we deem it appropriate to dispose of these petitions with a direction to the respondent-State to consider and decide the case of the petitioners, in light of the aforesaid judgments within a period of eight weeks. Ordered accordingly. However, while doing so, it shall always be open for the respondent-State to consider whether the petitioners or any one of them are fence-sitters and the effect thereof on their respective claim, as raised in these petitions. Pending application(s), if any, also stands disposed of”.

Whereas orders passed in LPA No. 102/2010 by the High Court of HP on dated 13.01.2012 were further agitated by state in SLP No (S) 1015/2014 which has been dismissed on 10.07.2017 by the Hon'ble Supreme Court of India .

And whereas Sh. Lekh Raj Sharma and others who were working as Shastri in the Education Department and were teaching Sanskrit to Classes VI to X had filed OA No. 2189 of 2003 before the HPAT claiming that the Shastri(OT) be treated to be equivalent to TGT from their initial appointment as they are being paid identical scale at par with TGT and they be granted promotion as lecturer in school cadre and also be promoted as Headmaster with all consequential benefits. The claim was rejected on 04.05.2010 by single Judge in CWP (T) No. 9567 of 2008. Since the R&P Rules of any category are framed under Article 309 of the constitution of India, for promotion to the post of Lecturers and Headmaster feeding post is TGT. Petitioner preferred LPA against orders dated 04.05.2010 and final judgment and order dated 13.01.2012 in LPA No. 102/2010 passed by the Hon'ble High Court of HP some petitioners having received identical scale at par with TGT were allowed promotion as lecturer School cadre in Sanskrit subject only. However their claim to get promotion as Headmaster was rejected.

And whereas existing R&P rules of any post is made under article 309 of Constitution of India. The R&P Rules of PGT cadre were notified on 20.09.2010. PGT is supposed to teach 6th to 10+2 classes . The PGT cadre has been renamed as Lecturer (School -New) w.e.f. 19.08.2019 the feeding post is TGT hence OT /Shastri and LT can not directly considered for promotion as PGT Sanskrit as such action will contrary to R&P Rules and all notified R&P Rules of all category JBT ,C&V and TGT. As per Finace department Notification dated dated 27.09.2012 category wise/post

wise Revised Pay the existing Grade pay of TGT has been enhanced from 3600 to 5000/- and Shastri 3200 to 4400/- .As per HPCS (RP) Rules,2022 the Level of TGT is 10 and level of LT and Shastri is 09.

Now therefore, the claim of Petitioner in LPA 102/2010 & CWPOA No. 863 of 2019 was based on identical scale at par with TGT for Headmaster and lecturer promotion against R&P Rules of Lecturer Schools notified on 28.12.1973 which has been repealed on 11.06.2009. The claim for Headmater promotion was rejected by Honble High Court in LPA 102/2010. In present petition, Petitioners have never received identical scale at par with TGT.Untill and unless petitioners gets identical scale and are placed in combined seniority of TGT by Director Elemenary Education they can not claim promotion as lecturer (School New). Accordingly the representation is considered and rejected.

May inform the parties accordingly.
