- 2. Inspired by Hon'ble PM's Pariksha Pe Charcha and continuing its endeavour towards changing the outlook/perspective of children towards exams and making it a joyful activity, NCPCR is conducting Pariksha Parv 2.0. During Pariksha Pe Charcha earlier this year, Hon'ble PM emphasised the significance of counselling and talking about one's problem. 
