

I am directed to refer to this Department's Notification No. FIN(PR)-B(7)-1/2021 dated Fin(PR)-B(7)-1/2021 dated 3rd January, 2022 vide which the Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 have been notified and to clarify that the provisions of these rules shall apply to the extent of Pay only and orders regulating all other allowances and entitlements by whatsoever name called, including HRA, TA/DA etc will be governed by existing orders and in the pre-revised scales, until separate orders are issued with respect to them.
