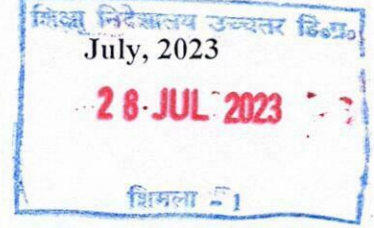

And whereas, it has also been brought to the knowledge of undersigned that in some cases, the interested School/College students are being dissuaded or prevented to use the School premises after the School/College hours which is counter-productive and quite detrimental in shaping the future of young generation.

Therefore, keeping in view the aforesaid facts and circumstances, it is expedient and necessary to allow the usage of School /College grounds for the purpose of sports activities only to the enrolled students of that particular School/College, purely at their own risk, so that they may be able to divert their energies towards the good cause of physical activities enabling them to refrain from bad habits.
