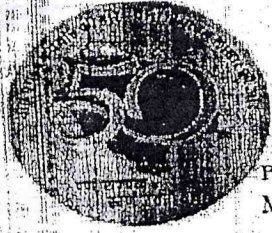


As per the Merit List issued for the distribution of laptops under
