
1. The Dy. Director of Hr. Education Sirmour (HP).

The Principals GSSS Puruwala/ Shivpur (Sirmour) with the direction that the incumbent working under your establishment be relieved immediately failing which disciplinary action will be initiated against the defaulter under the rules and also be ensured that there is no court case before relieving/joining the above said officials. If the controlling officer does not comply with this procedure, the salary of the surplus incumbent will be drawn from the salary of the controlling officer. The concerned Principals are also directed to ensure that consent be obtained before relieving and joining of both officials. It may also be ensured that the relieving/joining of incumbent may be entered in PMIS immediately. **It may also be ensured that in case of transfer in r/o NCC ANO these orders may not be implemented and intimate this Directorate immediately.**
