**ORDER**

Dated: Shimla-2, the 20-1-2024.

Whereas Sh. Prakash Chand, Principal, GSSS Ghatu, Distt. Kullu had approached the Hon'ble High Court vide CWP No. 10985 of 2023 for his transfer on the grounds couple case. The Hon'ble High Court decided the matter on dated 02.01.2024, the operational part of the judgement is as under:-

*"In these circumstances, this Court disposes of the present writ petition by directing the Respondent No. 1- Principal Secretary (Education) to examine/consider the representation dated 03.12.2023 (Annexure P-1) and the representation dated 17.12.2023 (Annexure P-2) and to pass appropriate orders, in the light of Clause 5.4 as referred to above, after affording a personal hearing to the petitioner, within ten days from today. Needless to say that, this Court has not adverted to the merits of the matter and all questions of facts and law are left open."*


2. Whereas, as per the directions of the Hon'ble High Court the petitioner was granted an opportunity of being heard in person on dated 15.01.2024. During the course of hearing the petitioner has submitted that his wife is working as Lecturer and posted in the Mandi District, therefore, he sought his transfer to GSSS Pairi, Distt. Mandi considering his couple case.
3. Whereas, the clause 5.4 of transfer policy provides that " In case wife and husband both are working under the state Government, efforts should be made to post them at one place or near places as far as possible, subject to vacancy" and further, the post of Principal is lying vacant at the station requested by the petitioner i.e. GSSS Pairi, Distt. Mandi.
4. Now therefore, the undersigned after careful consideration of all the facts and circumstances of the case decides to post Sh. Prakash Chand,


