In continuation of this Department Press Release even number dated 31st August, 2020 and 17th October, 2020 regarding applying and submitting of online application forms on National Scholarship Portal (NSP) https://scholarships.gov.in/ under the Pre-Matric, Post-Matric and Merit-cum-Means based Minority Scholarship Schemes implemented by the Ministry of Minority Affairs (MoMA), Govt. of India with 100% Central funding for the Session 2020-2021. Under these Schemes, Scholarships are awarded to the Economically weaker and Meritorious Students from Centrally notified minority communities viz. Buddhist, Christian, Jain, Muslim, Sikh pursuing studies in India in a Government or recognised Private University /Institute/College/School.

The Central Government has decided to extend the date upto 30th November, 2020 on National Scholarship Portal (NSP) for the year 2020-2I, as per the decision of DBT Mission. The timelines of filling up of forms for fresh and renewal applications for all 3 Scholarship Schemes has been extended upto 30th November, 2020. Other timelines are as under:-

The registration of fresh and renewal application forms is very slow. A large number of Schools/Institutes have either not applied for the registration or there registration is pending for approval at the level of District Nodal Officers (DNO)/State Nodal Officers (SNO). Therefore, all Head(s) of the Institutions(s) of Schools/Institutes are directed to complete the verification in time and send it to their respective DNO/SNO for verification at L2 level. The Schools/Institutes which are yet to complete the KYC process need to be pursued vigorously by DNO/SNO to complete the process so that, no deserving eligible child is left out from the benefit of Scholarship Schemes.
