insurance of equipment & students and POL and fund required for growth and development of the institution @ 15% as per the judgement of the Hon'ble Supreme Court. The committee took the view that claim as submitted by MMU cannot be passed on to the students completely as the infrastructure and equipments are being used by the Hospital as well and also by U.G. students.

The committee deliberated upon the apportionment of claim to the fee structure with MMU representative and the average fee structure per student was worked out as under:-

MMU representative further submitted that the proposed fee structure is based upon average student fee of 30.17 lac. Therefore, the committee decided that purposed course wise fee should be reduced by the factor equal to ratio of average fee arrived and proposed fee= $24,11,019\div3017000 = 0.80$. As regard the hostel fee is based upon report of

sub-committee i.e. Rs. 96000/- per student per annum . As per the new factor the fee structure would be as per annexure "A".

It was unanimously decided that:-

- The fee structure for PG Course (s) will be the same for consecutive three batches i.e. 2019-20, 2020-21 & 2021-22.
- 2. Fee will not be increased till the completion of the course i.e. it will remain fixed for three years duration of the course.
- 3. The excess fee charged from the students who were enrolled for PG Course (s) in the academic session 2019-20 will be adjusted in the year 2020-21.
- 4. That MMU will pay stipend as proposed by them at the rate of Rs. 40,000/- per month or at the rate at par with IGMC Shimla whichever is higher.

The recommendation of the fee structure committee may be sent to the Govt. as per the procedure for final approval of the fee structure.

The meeting ended with a vote of thanks to the chair.
