**These posting are subject to the following conditions: -**

1. The Promoted JLA(s) will join their new place of posting (s) within 05 days from the date of issue of orders positively, failing which promotion orders shall have deemed to be withdrawn automatically for **one year or next DPC whichever is earlier**. No specific orders with reference to withdrawal of promotion orders will be issued separately. **No extension will be given for joining in any case.**
2. The financial benefits will be admissible from the date of joining on the post of JLA. He/ She will be entitled TA/DA and joining time as admissible under the rule. He /She will have to exercise their option within one month from the date of promotion for fixation of pay under rule FR22 (i) a (i).
3. The promotee should report for duty to the concerned institution within stipulated period. The Concerned Principal will relieve the promoted Junior Lecturer Assistants immediately. The salary of the promoted SLA for the next month will be drawn from the College from his/ her post. If the promoted SLA is not willing to avail the promotion he/she has the right to forgo the promotion, the Principal will take the option of non-availing the promotion from the concerned Junior Lecturer Assistant(s) and the same may be recorded in his /her service book and the other copy (s) be sent to this Directorate for taking further action.
4. In case the above promotee has been transferred to other institutions, the concerned Principal will ensure to send the promotion order to the institution where he has been transferred and report thereof be sent to this Directorate immediately.



5. In case the concerned promotee does not report for duty in the institution within stipulated period, the next incumbent in panel will be promoted. The Principal will ensure the submission of joining/non-joining report to this Directorate within a week after the expiry of stipulated period.
6. The Principal of the concerned institution shall take an undertaking of the concerned official to the effect that if he/she is found unfit for promotion at a later stage due to any reason i.e. any change in the seniority / disciplinary proceedings etc, he will be reverted to the original post of Junior Lecturer Assistants and the excess amount paid to him will be recovered in lump-sum. The same be pasted in service book of concerned official duly countersigned by the Head of Institution.
