"ORDER"

Whereas the petitioner Raj Kumar, Lecturer(SN) History is working at GSSS Dharmehar, Distt. Mandi w.e.f. 05.08.2019 & as such his stay is complete. Feeling aggrieved he filed CWP No 7802/2022 titled as Raj Kumar Vs State of H.P before the Hon'ble High Court regarding his transfer. This petition was listed before Hon'ble High Court on dated 09.11.2022 when the same was finally disposed with the directions to respondents as under:-

"Accordingly, without going into the merits of the case, we dispose of the present writ petition by permitting the petitioner to make afresh reprentation to respondent No. 2. If such representation is made within one week from today, the same shall be decided by respondent No. 2 not later than four weeks from the date of receipt of the representation, Pending miscellaneous application, if any also be stand disposed of."

And whereas, upon passing of above direction the representation of petitioner has been received on dated 12.12.2022 in which he has opted GSSS(B) Joindernagar, Distt. Mandi against vacancy being caused due to retirement of present incumbent on 31.03.2023 which cannot be considered at this earlier stage. Moreover, as per transfer policy the incumbent on completion of normal tenure in difficult/tribal/hard area will have an option of five stations of choice which will be for more than one District and as far as possible, efforts will be made to post them in any one station of their choice of the category of station in which he/she has not served earlier. Whereas , the petitioner has already served in that category of station of his choice near about nine years.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that as the petitioner has not opted any existing vacancies. However, available vacancies were offered to him but he refused to accept by stating that there is no suitable vacancy of Lecturer History nearby his native place.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner can not be acceded to. Hence, representation is hereby rejected to the extent that he may represent a fresh as and when the vacancy exists as per his choice of stations and same will be decided separately as per transfer policy and till than he will continue at GSSS Dharmehar Distt. Mandi.

May inform the parties accordingly.
