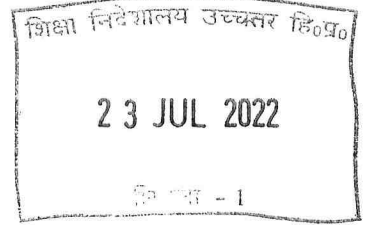

It may also be ensured that the relieving/joining of incumbent may be entered in PMIS immediately. **The concerned Principals are also directed to ensure that consent be obtained before relieving and joining of the officials. It may also be ensured that in case of transfer in r/o NCC ANO these orders may not be implemented and intimate this Directorate immediately**
