ORDER

Whereas, Sh. Rajinder Kumar, Lecturer (School-New) (Economics) has filed CWP No. 9029/2024 before the Hon'ble High Court for seeking his transfer from GSSS Kewar, Distt. Shimla to his choice of stations i.e. GSSS Namhol (BLP)/GSSS Dargi (SML)/GSSS Chandi (S) (SLN) against vacant post due to zero enrollment in Economics subject at GSSS Kewar (SML).

The case was finally listed before the Hon'ble High Court on 24.08.2024 when the case was disposed of with the following directions:-

"Learned counsel for the petitioner submits that the petitioner has filed representation Annexure P-2 with regard to the issues raised in the petition and it would be in the interest of justice, in case the representation of the petitioner be decided, within some time bound manner".

"Accordingly, as prayed for, this petitioner is disposed of with the direction that let representation Annexure P-2 of the petitioner be decided by the Competent Authority, in the light of the averments made therein, within a period of six weeks from today, in accordance with law. However, it is made clear that this Court has not expressed any observation as far as the merits of the case is concerned. Pending miscellaneous application(s), if any, also stand disposed of accordingly"


And whereas, upon passing of above directions, petitioner has submitted a fresh representation and requested to transfer him from GSSS Kewar (SML) to GSSS Namhol (BLP)/GSSS Dargi (SML)/GSSS Chandi (S) (SLN) against vacant post.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a request of petitioner is considered sympathetically and the petitioner i.e. Sh. Rajinder Kumar, Lecturer (School-New) (Economics) is being transferred from GSSS Kewar (SML) to GSSS Dargi (SML) against vacancy without TTA/JT as per his request.

With these observations, representation stands disposed of.
