ORDER

Whereas, Sh. Rakesh Kumar, Lecturer (School-New) (History) has filed CWP No. 9111/2024 before the Hon'ble High Court for seeking his transfer from GSSS DIET Jukhala, Distt. Bilaspur to his choice of stations i.e. GBSSS Ghumarwin (BLP) against vacant post or GSSS Sohal (BLP) against vacant post being caused due to retirement of present incumbent on 30.6.2024 on the ground that her daughter is suffering from 80% Locomotive Impairment.

The case was finally listed before the Hon'ble High Court on 12.06.2024 when the case was disposed of with the following directions:-

"Having heard learned counsel for the petitioner as also learned Additional Advocate General, this petition is accordingly, disposed of with the direction that let representation file by the petitioner be decided within the period of two weeks from today, sympathetically, in view of the facts mentioned therein as well as medical certificate of the girl child of the petitioner".


And whereas, upon passing of above directions, the representation of the petitioner has been perused and examined and found that post of Lecturer (History) is not lying vacant at GBSSS Ghumarwin/GSSS Sohal, Distt. Bilaspur. After that petitioner was directed to submit fresh representation alongwith available vacancy of his choice vide this office order dated 15.07.2024 and petitioner submitted his representation and requested to transfer him to GSSS Chalehli, Distt. Bilaspur, against vacant post.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a request of petitioner is considered sympathetically and the petitioner i.e. Sh. Rakesh Kumar, Lecturer (School-New) (History) is being repatriated from DIET Jukhala (Bilaspur) to his parent department and further transferred to GSSS Chalehli (Bilaspur) against vacant post without TTA/JT as per his request.

With these observations, representation stands disposed of.
