At the outset, the Chairman welcomed all the participants and thereafter it was apprised that chronological details of granting extension to National/State Awadee teachers is as follows:-

- In 1985, the State Government made a provision to grant a two-year extension in service for National Awardee Teachers and a one-year extension for State Awardee Teachers with the purpose of honoring and providing social recognition.
- This practice continued until 2003 when it was decided to grant a cash reward of Rs. 50,000/- to National Awardee Teachers and Rs. 25,000/- to State Awardee Teachers instead of extension in service.
- In 2010, the reward money was enhanced to Rs. 60,000/- for National Awardee Teachers and Rs. 40,000/- for State Awardee Teachers.
- On September 4, 2015, the Cabinet decided to grant a two-year extension in service along with one additional increment to National Awardee Teachers and a one-year extension to State Awardee Teachers. This decision was notified through the Department's letter/Notification dated 24-09-2015.

- It was further clarified in the Department's letter dated 30-11-2015 that National/State Awardee Teachers who had already received the cash reward for receiving awards would have the option to get one/two years of service extension, provided the cash reward received by such teachers is deducted from their salary in twelve equal installments.
- Furthermore, in a meeting held on 19th June, 2023, the Cabinet decided to engage National and State Awardee Teachers on fixed wages after their retirement.
- 2. In pursuance to above cabinet decision, detailed deliberation were made regarding implementation of same & following was recommended:
 - a. The National/State Awardee Teachers will now be engaged on fixed wages after their retirement, as per details given below:-

| Category of Teacher | Per month fixed wages |

| TGT IBT HT CHT. C&V. PET | Rs. 20,000/- |
| Lect PGT DPF Headmaster | Rs. 25,000/- |

- b. The National/State Awardee Teachers will give option for such engagement six months before their retirement.
- c. Those awardee teachers who will not opt for re-engagement will be given fixed cash reward of Rs. 60,000/- for National Awardee Teachers and Rs. 40,000/- for State Awardee Teachers. The DDO concerned will be authorized to draw the cash reward and make payments in favour of awardee teacher.
- d. Such re-engaged teachers will be liable to be posted anywhere in the state upon their re-engagement.

The meeting concluded with a vote of thanks from & to the chair.
