Sectt. Shimla-171002 to discuss various important matters pertaining to the Higher Education in the State.

I am directed to enclose herewith a photocopy of minutes of the departmental review meeting in which (Item No-11) it has been decided that before lifting ban on transfer, a general instruction may be issued for those employees already working in the Tribal Area and have completed their normal tenure, will submit their application with five choice of stations against vacancy to the DHE/DEE before 15<sup>th</sup> March, 2025 and after scrutiny the same both the Directors will submit the proposals before 20<sup>th</sup> March, 2025 for further approval of the Govt. After lifting of ban on transfers, transfers will be allowed between 1-4-2025 to 30-04-2025 in School Cadre and for College Cadre it will be 1-05-2025 to 15-05-2025. Further, transfer will be considered from normal areas who have completed 3 years of service in a station. Mutual transfer will not be considered.

You are therefore requested to issue necessary instructions in this behalf today positively.
