
Regarding Celebration of Road Safety Week.

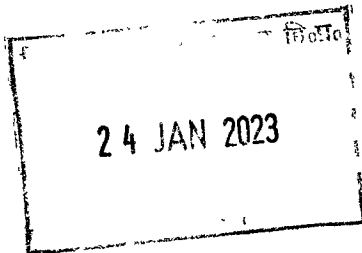



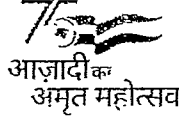
