**ORDER**

**Whereas**, Sh. Sandeep Baret, Lecturer (School-New) (English) was transferred from GSSS Kathog (SML) to GBSSS Theog (SML) vice Smt. Pratibha Devi Chauhan, Lecturer (School-New) (English) who was transferred to GSSS Annadale (SML) vice Smt. Kiran Bala, Lecturer (School-New) (English) who was further transferred to GSSS Kathog (SML) in place of Sh. Sandeep Baret vide this office order of even number dated 04.03.2024. Against these orders Smt. Pratibha Devi Chauhan and Smt. Kiran Bala filed CWP No. 1745-1846/2024 before the Hon'ble High Court. The case was finally listed before the Hon'ble Court on 13.05.2024 when the Hon'ble Court has disposed of the same with the following directions:-

"After hearing learned counsel for the parties for some time, as prayed for, these petitions are disposed of with liberty to the petitioners as well as private respondent to move appropriate representations for their adjustment at some other station in light of hardships that have been submitted by them, which they shall reflect in their representations. In the event of any such representation being filed by them within a period of two weeks from today, the same be decided by the Competent Authorities sympathetically within a period of two weeks as from the date of receipt thereof. Till then, status quo be maintained. Due and admissible salary of the parties be also released in the interregnum. Pending miscellaneous applications, if any, also stand disposed of."


**And whereas**, as per the direction passed by the Hon'ble High Court as above, petitioner as well as private respondent submitted their representation vide which they were requested to retain all of them at their present place of posting due to their adverse family circumstances.

**And whereas**, representations of petitioner and respondent were not decided as they were not submit any other vacant station in their representation. Therefore, to decide the said CWP they were called to appear in person on dated 11.07.2024. During the course of hearing, it is decided between petitioner and private respondent that petitioners will be retained at their present place of posting and private respondent will be adjusted at GGSSS Theog (SML) against Smt. Kuntla, Lecturer (English) who is likely to be promoted as Principal.

**Now therefore**, a request of the petitioner and private respondent has been considered and Smt. Kiran Bala and Smt. Pratibha Devi Chauhan are retained at present place of posting and Sh. Sandeep Baret, Lecturer (School-New) (English) who has already joined at GBSSS Theog (SML) is also retained at GBSSS Theog (SML) till the vacancy in the subject is available at GGSSS Theog (SML) being caused due to promotion of present incumbent as Principal. Pay lien of Sh. Sandeep Baret, Lecturer (School-New) is hereby fixed at GSSS Kathog (SML) against the vacant post of Lecturer (English).

With these observations, representation stands disposed of.

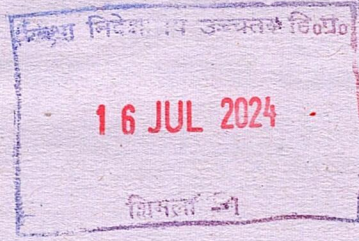
