Subject:- Regarding changing of INO by the institute and furnish the information about the INO change in the format.

Sir/Madam,


It is to bring to the kind notice that during previous year various media reports have been published alleging large scale embezzlement of funds in many states under the Scholarship Schemes implemented by the Ministry of Minority Affairs. It alleged that fake beneficiaries and fake Institutions are getting scholarships in connivance with School, Institute Nodal Officers (INO) and banking correspondent (BC).

To revamp and clean the process of disbursement of scholarships, the Ministry launched a special drive for Aadhaar Based bio authentication of all Nodal Officers and applicants through a utility developed by CSC-SPV. The drive was monitored under strict SoP formulated by the Ministry of Minority Affairs.GOI.

Some institutes may have changed INO before or after bio-authentication Regarding changing of INO by the institute, information as per prescribed proforma be sent to the Directorate of Higher Education H.P. within four days i.e. **upto 04-10-2023**. Information may be provided by only those institutes who have done bio-authentication of INO/HOI w.e.f.05-08-2023 to 16-09-2023 under Minority Scholarship Schemes.
