Sir/Madam,

Kindly refer to this Directorate office order No. EDN –H(10)F(4)60/2009-MISC-VOL-III dated 28-07-2022 vide which detailed instructions regarding registration of Educational Institution and submission of scholarship applications through National Scholarship Portal was elucidated. At Page no. 17, it is clearly mentioned that Income Certificate must be in the name of the Parents / Guardian and not in the name of students.

During the course of verification of scholarship applications in the current Academic Session 2022-23, it has been noticed that Income Certificate has not been issued in favour of Parent/ Guardian and it has been prepared in the name of concerned student(s), which is a matter of great concern.

According to the scheme guidelines of the scholarship schemes, Income Certificate must be in the name of Parent/ Guardian.

In view of above, it is once again directed that at the time of verifying the Scholarship Applications only those Income Certificates may be accepted which has been prepared in the name Parent/ Guardian of the student(s) and the Income Certificate which has been issued in favour of student(s) may not be accepted. All instructions as per the guidelines of scholarship schemes and instructions circulated in details in office order of this Directorate on 28-07-2022, must be adhered strictly, please.
