Please refer to this office letters even number, dated 23-04-2021, 02-06-2021 and 19-07-2021 on the subjects cited above vide which an amount of Ps.2,56,35,000-only (Two Crore, Fifty Six Lakhs and Thirty Five Thousand only), was released from this office for Non-Structural Mitigation under School Safety Project. The same amount was distributed further to all the Deputy Directors of Higher Education, through RTGS to complete various activities/ works under this programme in schools, on the basis of number of schools in different Districts. It was also directed that these funds should not be parked in bank accounts and should be utilized for the purpose for which released after completing all codal formalities and accounting procedures.
