"ORDER"

Whereas the petitioner Smt. Shelja Kumari, Lect./Lect.(SN) Chemistry is working at GGSSS Bilaspur, Distt. Bilaspur w.e.f. 24.06.2020 & as such her stay is complete. Now she is seeking her transfer to the station of her choice and filed CWP No 3354/2023 titled as Shelja Kumari Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 30.05.2023 when the same was finally disposed with the directions to respondents as under:-

"Learned counsel for the petitioner has submitted that petitioner shall be satisfied in case she is permitted to file a fresh representation to respondent No. 2/ the Director (Higher Education), within three days and the same is decided in a time bound manner.

Learned Deputy Advocate General submits that in case such representation is preferred by the petitioner, same shall be decided in accordance with law, as expeditiously

In view of above, petitioner is permitted and directed to submit a fresh representation to respondent No. 2/ the Director (higher Education) and in case, such representation is preferred on or before 02.06.2023, the same shall be decided by respondent No. 2 on or before 30.06.2023, by passing an appropriate speaking and reasoned order in accordance with Rules, Policy and law as applicable.

Needless to say that order shall be passed after giving the personal hearing to the petitioner, if desired so. Till the decision of representation, in case stations mentioned in the representation are lying vacant, at least one of such stations shall be kept vacant, if not already filled.

Petition stands disposed of in the aforesaid terms, along with pending

miscellaneous application(s), if any."

And whereas upon passing of above directions, the petitioner represented to the undersigned on dated 01.06.2023 & another one 17.07.2023 along with the copy of the directions dated 30.05.2023 passed by the Hon'ble High Court, HP. She has requested for her transfer from GGSSS Bilaspur, Distt. Bilaspur to the stations of her choice i.e GGSSS Mandi/ DIET Mandi/ GBSSS Mandi/ Talyahar/ Bhangrotu/ Bagla, Distt.

And whereas, as per direction passed by the Hon'ble High court as above, a request of petitioner has been examined and also perused the record and observed that at present there is no vacancy

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and accepted to the extent that she may represent a fresh as and when the vacancy exists as per her choice of stations and same will be decided separately as per transfer policy. Accordingly his representation stand disposed of.
