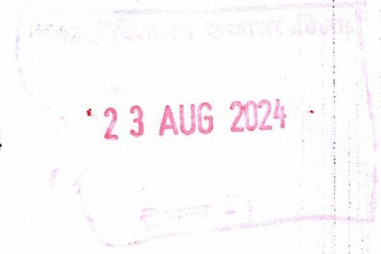

Minutes of the meeting of 'Shiksha Saptah' held on 16 July 2024

A meeting to discuss plans for celebrating and working out the modalities for implementing the Shiksha Saptah with the Education Secretaries/SPDs of all states/UTs was held under the chairpersonship of Sh. Sanjay Kumar, Secretary, DoSE&L on 16th July, 2024 at 04:00 PM in hybrid mode.

2. While welcoming all the participants, Shri Sanjay Kumar, Secretary(SE&L) mentioned the objective of celebrating Shiksha Saptah.
3. Sh. Vipin Kumar, Additional Secretary, DoSE&L then emphasized the importance of Shiksha Saptah in fostering the spirit of collaboration and innovation among students, educators, community people and other stakeholders. A detailed presentation on each dedicated day of Shiksha Saptah was made by highlighting the monitoring mechanism for activities to be celebrated during each day of the event.
4. The major points which were discussed during the meeting are as follows:
 - i. The importance of celebrating thematic days under Shiksha Saptah in schools is to convey lifelong learning message.
 - ii. Concept notes with suggested activities tailored to each theme were shared with States/UTs to promote learning and community involvement.
 - iii. It is expected from the states/UTs to promote these suggested activities which have been created to promote learning among students and encourage community involvement in schools.
 - iv. States were requested to commence the Shiksha Saptah pro-actively to promote dedicated activities and massive participation of students, teachers, community people and other stakeholders as expected.
 - v. Inclusion of KVS/NVS, SCERTs, DIETs, and private schools in conducting themed activities was recommended.
 - vi. A few states raised concerns regarding feasibility of timings, duration, and suggested activities. For instance, schools in Himachal Pradesh might be closed during the planned period.
 - vii. DoSE&L suggested minor flexibility in duration/day to allow states to celebrate dedicated activities and advised all States/UTs to share the event information with this Department.
 - viii. A Google tracker/drive to monitor participation and to capture photos/videos of the event will be created at DoSE&L level.

The meeting concluded with a vote of thanks.
