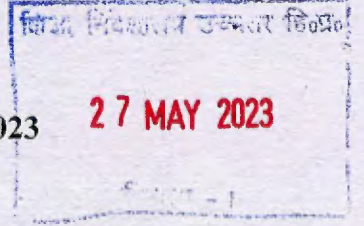



Identification of Higher & Senior Secondary Schools for organizing Cultural, Slogan writing, poster and painting competition on the occasion of Environment Day on 5th June, 2023.

Sir,

As you aware that Environment day is being celebrated every year on 5th June since 1992, focusing on raising awareness on environmental issues such as marine pollution, water pollution overpopulation, global warming, sustainable development etc. Jal Shakti Department, Himachal Pradesh also celebrate the Environment Day in the State by sensitizing the local community through different programmes or campaigns. In this context, it has been decided that the Environment day shall be celebrated for this year at school level by including school children, teachers, PTM etc. focusing on Water Quality & Sanitation, Water availability, Water conservation & Rain water harvesting, Water borne diseases & personnel hygiene etc.

As a part of this event Environment Day shall be celebrated in 3 no. of higher schools (GSSS/GHS) in every developmental block i.e. 264 functions shall be organized in which officers/officials EE/AE/JE/BRCs, departmental persons will also participate by closely associating with local Jal Mirtra, PRIs, VWSCs, SHGs other inline departments, NGOs etc. The function will be organized for about 2 hours in which following activities shall be undertaken:

- Cultural Programmes /Slogan writings /Poster & Painting Activities
- Declamation & Quiz competitions etc.
- School Children Rallies.

To organize these events/functions at block level Rs. 6000/- shall be provided to each identified school for reward, refreshment & other logistics. It is therefore, requested that GSSS/GHS schools may please be identified to organize this activity. District wise list shall be submitted to distt. HQ Executive Engineer i.e. Member Secretary (DWSM) cum Executive Engineer to release the payments to schools so that function can be organized accordingly.
