The Governor, Himachal Pradesh is further pleased to delete Clause-10 and to add a Proviso to Clause-9 of the SMC Policy notified by this Department Notification No. EDN-C-A(4)1/2011, dated 17th July 2012, as under:-

Law
"Provided that the regular/contract teachers shall be posted preferably against the clear cut vacancies where the SMC teachers are not in position. After all the clear cut vacancies are filled up only then the posting may be made against the SMC teachers."

These provisions shall come into force with immediate effect.

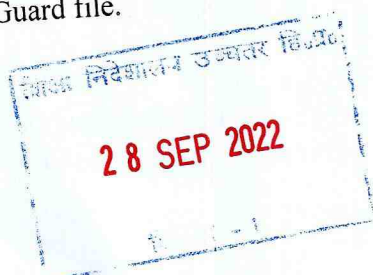
