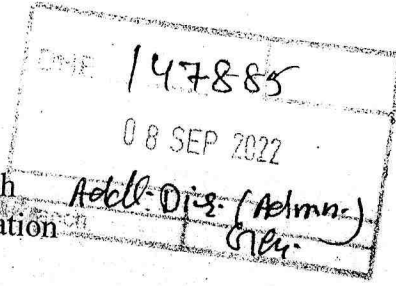

New Delhi, the 30<sup>th</sup> August, 2022

Respected Member,

Shri S.S. Ahluwalia, Hon'ble MP (Lok Sabha), during the XVII-VIII Lok Sabha Session 2022 on 21.03.2022, has submitted that the percentage of Children with Special Needs (CWSN) studying in schools in rural and urban areas is low due to non-issuance of disability certificate.

2. It has been emphasized that CWSN has to visit district hospital to obtain disability certificates and the parents/ guardian of CWSN has scarcity of time for appearing before the Medical Board. This problem should be addressed and the assessment of CWSN and issuance of disability certificate should be made available in schools itself through camps.

3. Hon'ble Speaker, Lok Sabha has suggested Hon'ble Education Minister to advise States/ UTs to make a provision to issue disability certificates in schools through camps.

4. I shall be grateful if you could look into the matter personally to smoothen the process of issuance of Disability Certificates at schools by organizing camps at block/ cluster level for maximum coverage and sensitize CWSN about exam accommodations and other entitlements provided in schools.
