"OFFICE ORDER"

In continuation to this Directorate officer order of even No. dated 15-01-2024 and in compliance to the directions / orders passed by the Hon'ble High Court of HP on dated 13-10-2022 in CWP No.3096/2019 titled Rakesh Kumar & Ors Vs State of HP and CWPOA No. 4421/2019- Sanjeev Kumar Vs State of HP & Ors and similar situated cases and approval of the Govt. of Himachal Pradesh conveyed vide letter No. EDN-A-E(5)-2/2019-L-II dated 18-10-2023 and approved by the pay scale/UGC scales of Rs 15600 + Rs 6000 GP is hereby awarded from date of regularization to the following Assistant Librarians on the analogy of the CWP(T) 4436 /2008 - V.D. Saraswati & others V/s State of HP and LPA 146/2009 - State of HP V/s V.D. Saraswati & others subject to the final outcome of LPA on the matter. Further in compliance to approval vide letter number EDN-A-E95)-2/2019-L-II, dated 15.12.2023 and further approval on file from competent authority on dated 06-01-2024, above incumbents are posted along with post in the Govt. Colleges and Central State Library Solan, HP State Library Shimla, Govt. Distt. Libraries, Govt. Tehsil /Community/Tribal Libraries as mentioned in column 4 of table below, with TTA/ JT with immediate effect:-

1. The above mentioned Assistant Librarians are directed to join their duties at place of posting and submit their joining report to this Department through proper channel within a time span as prescribed vide Finance Department's Notification No. Fin (C) B (7) 1/2023 Dated 24-5-2023 i.e 30 Kms or less in one day and more than 30 Kms in five days from the date of issuing of orders) failing which it will be assumed that they are not interested to have UGC scale .Further the above pay scale is admissible only after jointing of new place of posting. No extension will be available in any case for joining. All the Concerned College Principals with the directions to send the fixation case of the above Assistant Librarians along with service book after their joining in your institution.
2. All those petitioners(Assistant Librarian) who are serving in the Govt. Colleges and Central State Library Solan, HP State Library Shimla, Govt. Distt. Libraries, Govt. Tehsil /Community/Tribal Libraries and are not in receipt of UGC pay scale are also hereby allowed the same from the date of regularization.
3. All those petitioners (Assistant Librarian) who were serving in Govt. school, Govt. Colleges and Central State Library Solan, HP State Library Shimla, Govt. Distt. Libraries, Govt. Tehsil /Community/Tribal Libraries and were not in receipt of UGC Scale and are now retired are also hereby allowed the same from the date of regularization.


4. All those Assistant Librarian who are in receipt of UGC Scale and are presently working under deputation in Govt. Colleges and Central State Library Solan, HP State Library Shimla, Govt. Distt. Libraries, Govt. Tehsil /Community/Tribal Libraries are hereby also stand to be shifted along with the post in these institutions.

5. However the arrears in r/o petitioners will be restricted for three years prior to filling of the case and for Non-petitioners w.e.f.18-10-2023 i.e. the date of approval of the state Government to implement court order. Incumbent Assistant Librarians will have to give an undertaking that he/she will not claim any past arrears. Further, for arrears, the Notification No.Fin-E-1-C(17)-6/08 dated 07.01.2012 of Finance department be adhered.

6. The undertaking be taken from the concerned Assistant Librarian, duly countersigned by the DDO to this effect that if the LPA is decided in the favour of the State and against the interest of the petitioners, the entire arrears received by them till date shall be deposited in lump-sum in Govt. Treasury and this undertaking shall be pasted in the service book of the concerned.
