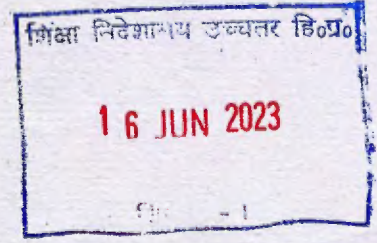

ORDER

Whereas, Sh. Surender Singh, Lecturer (School-New) (English) has filed CWP No. 3259/2023 before the Hon'ble High Court regarding his transfer from GSSS Kamroo, Distt. Sirmour to nearby station or GGSSS Paonta Sahib, Distt. Sirmour against vacancy being caused due to retirement of Sh. Raj Kumar on 30.06.2023. The case was listed before the Hon'ble Court on 29.05.2023 when the case was disposed of with the following directions:-

"Petitioner is permitted and directed to submit representation in terms of policy to respondent No. 2 –Director of Higher Education on or before 3rd June 2023 and in case such representation is preferred by the petitioner, the same shall be decided by respondent No. 2 on or before 28.06.2023, by passing speaking and reasoned order after giving opportunity of hearing to the petitioner, if desired so. Order shall be communicated to the petitioner"


And whereas, upon passing of above directions, petitioner, Sh. Surender Singh, Lecturer (School-New) (English) submitted his representation and requested to adjust him at nearby station or GGSSS Paonta Sahib (SMR) against vacancy being caused due to retirement of Sh. Raj Kumar, Lecturer (English) on 30.06.2023.

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered and found that at present the post of Lecturer (English) is not lying vacant at nearby station and only post is going to be vacant at GGSSS Paonta Sahib (SMR) on 30.06.2023 due to retirement of Sh. Raj Kumar. Hence, the petitioner i.e. Sh. Surender Singh, Lecturer (School-New) (English) is hereby transferred from GSSS Kamroo (SMR) to GGSSS Paonta Sahib (SMR) against vacancy being caused due to retirement of Sh. Raj Kumar, Lecturer (English) on 30.06.2023 in condonation of short stay & without TTA/JT. **These orders shall come into force on or after 01.07.2023.**

With these observations, representation stands disposed of.


