The Chairperson of the District level Suposhan Task Force may co-opt other members to assist the committee in its task or invite to the meetings special invites such person as may be deemed necessary. The Committee shall meet at least once in a quarter and when required on notice of the Chairperson.

The District level Suposhan Task force will be responsible for the following functions:

- The overall monitoring of the 7 pillars of MMBSY at District level shall be done by District level Suposhan Task force on monthly basis.
- The Task force will decide the quality protein nutrition items to be provided under this
 programme in consultation with nutrition counselors as per the regional food
 preferences of beneficiaries.
- This Task force will monitor the management of funds received by the concerned DPO.
- Transparent mechanism for procurement and distribution of special supplementary nutrition shall be undertaken by this Task force. The Task force will decide the level of procurement of items whether to be done at District/Block/Supervisor/AWW level.
- This Task force will approve the source/mode of procurement of nutrition items if the procurement is done by DPO at District level.

- The quality of food item shall be ensured by this Task force.
- Data assessment of all the Blocks will be collated at this level by line Departments.
- An assessment of the gaps and lagging interventions shall be undertaken by this Task force.
- This Task force shall identify the Blocks which are performing poorly and identify clear actions to be undertaken to address these gaps.
- Seek assistance from the State for redressal of any identified gaps.
- To review quarterly and annual targets set by Blocks by specifically analyzing the proceeding of the meeting of Task force at Block level.

The Task Force will meet at least quarterly or earlier as and when required on the notice of the Chairperson and will submit its review report to State level Suposhan Task force clearly outlining the action taken at the district level & block level and support required from the State Govt.

The Chairperson of the Block level Suposhan Task Force may co-opt other members to assist the committee in its task or invite to the meetings special invites such person as may be deemed necessary.

The Block level Suposhan Task force will be responsible for the following functions:

- The overall monitoring of the 7 pillars of MMBSY at Block level shall be done by Block level Suposhan Task force on monthly basis.
- This Task force will approve the source/mode of procurement of nutrition items if the procurement is done by CDPO or Supervisor or AWW Block level.
- The Task force will be responsible for the overall monitoring of the distribution of the food items at the Block level.
- The codal formalities required for procurement of the food items shall be done by the concerned CDPO as per provisions of HPFR.
- Random testing shall be done by this Task force after receipt of stock at the AWC or at
 the Block level. The CDPO or Supervisor shall draw the samples, as per the prescribed
 procedure and send the sample for testing to a FSSAI owned/registered/ empanelled/
 NABL accredited laboratory in a quarter.
- This Task force shall ensure the quality of food items.
- An assessment of the status of key interventions will be done at the Block level in convergence with the line Departments.
- Identification of the gaps & clear cut actions to be undertaken.
- Redressal mechanisms.

- Quarterly and annual targets to be achieved shall be formulated at this level.
- Review quarterly and annual targets set by Panchayats by specifically analyzing the proceeding of the meeting of Task force at Panchayat level.

The Committees will meet at least once quarterly or earlier as and when required on the notice of the Chairperson and will submit its review report to District Level Task Force clearly outlining the action taken at Block level and support required from the State Govt.
