
Sir,

The H.P. State Institute of Rural Development, HIPA, Fairlawn, Shimla-171012 has proposed five days ToT programme on Sustainable Development Goals (SDGs) w.e.f. 27-31<sup>st</sup> December, 2021 at HIPA.

All the training costs, except lodging and travel costs, will be borne by the Institute. The participants will pay the lodging charges at state cost norms and get it reimbursed from their respective departments. The nominated participants should be double vaccinated or with 72 hours RT-PCR report as per the COVID-19 protocols. In addition to this, the officers/officials nominated for the training may be advised strictly NOT to bring vehicles-officials or personal and NO ward/family members during the training programme. The Institute plies its two buses in local Shimla area in morning and evening which service can be availed of. The bus time table is available on the website of the Institute.
