ORDER

Whereas, Sh. Rajinder Singh, Superintendent Gr-II was transferred from GSSS Govt. PG College Sangrah (SMR) to GSSS Sirkund (CBA) vide this office order of even number dated 31.08.2023 in public interest. Against these orders Sh. Rajinder Singh filled CWP No. 6177/2023 before the Hon'ble Court regarding his suitable adjustment in GSSS Govt. Degree College Nohradhar (SMR) or Govt. Sanskrit College, Nahan or in the office of Deputy Director Higher Education against vacant post being medical problems of his wife. The case was finally disposed of by the Hon'ble Court on 04.08.2023 with the following directions:-

"In view of above submission, this writ petition is disposed of by permitting petitioner to make a representation to respondent No.2/competent authority within a week from today which shall be considered in accordance with law and applicable policy, within a period of one week thereafter. The decision so arrived at shall also be communicated to the petitioner."

And whereas, upon passing of above directions, petitioner, Sh. Rajinder Singh, Superintendent Gr-II submitted a representation and requested to adjust him in Govt. Degree College Nohradhar (SMR) or Govt. Sanskrit College, Nahan or in the office of Deputy Director Higher Education against vacant post being medical problems of his wife.


And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Superintendent, Gr-II is lying vacant at Govt. Degree College Nohradhar (SMR) and Govt. Sanskrit College, Nahan. But, while considering his representation, it is found that he is serving in Distt. Sirmour since his first appointment. Therefore, being a State Cadre he can be transfer anywhere in H.P.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner who is under orders of transfer from PG College Nahan (SMR) to GSSS Sirkund (CBA) has been considered and further adjusted at suitable station i.e. GSSS Khajjiar (CBA) against vacancy.

With these observations, representation stands disposed of.
