ORDER

Whereas, Sh. Sundar Lal, Lecturer (School-New) (English) was filed CWP No. 5298/2023 before the Hon'ble High Court regarding his transfer from GSSS Kashimblidhar, Distt. Mandi to choice of his stations i.e. GSSS Badhu or GSSS Kothi Gehri or GSSS Nasloh Distt. Mandi against vacancy as he is suffering from a Chronic and Fetal Disease CML and taking treatment from PGI Chandigarh and having old aged parents. The case was listed before the Hon'ble Court on 10.08.2023 when the case was disposed of with the following directions:-

And whereas, upon passing of above directions, petitioner, Sh. Sundar Lal, Lecturer (School-New) (English) submitted a representation and requested that due to his medical problems and old aged parents he is not able to serve at GSSS Kashimblidhar (MND). He further requested to adjust him at GSSS Nasloh or GSSS Gokhra or GSSS Badhu, Distt. Mandi against vacant post.

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathetically and the petitioner i.e. Sh. Sundar Lal, Lecturer (School-New) (English) is hereby transferred from GSSS Kashimblidhar (MND) to GSSS Badhu (MND) against vacancy in condonation of short stay & without TTA/JT.

With these observations, representation stands disposed of.
