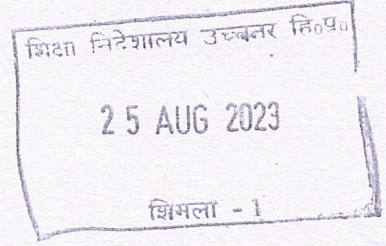

**ORDER**

**Whereas**, Sh. Sundar Lal, Lecturer (School-New) (English) was filed CWP No. 5298/2023 before the Hon'ble High Court regarding his transfer from GSSS Kashimblidhar, Distt. Mandi to choice of his stations i.e. GSSS Badhu or GSSS Kothi Gehri or GSSS Nasloh Distt. Mandi against vacancy as he is suffering from a Chronic and Fetal Disease CML and taking treatment from PGI Chandigarh and having old aged parents. The case was listed before the Hon'ble Court on 10.08.2023 when the case was disposed of with the following directions:-

**"In view of above, this writ petition is disposed of by directing respondent No.2/competent authority to decide the representation of the petitioner (Annexure P-3), taking into consideration the facts mentioned in the writ petition as well as the stations indicated in para-8 thereof, in accordance with law and applicable policy, within a period of seven days from today. The decision so arrived at shall also be communicated to the petitioner. The pending miscellaneous application(s), if any, also to stand disposed of."**

**And whereas**, upon passing of above directions, petitioner, Sh. Sundar Lal, Lecturer (School-New) (English) submitted a representation and requested that due to his medical problems and old aged parents he is not able to serve at GSSS Kashimblidhar (MND). He further requested to adjust him at GSSS Nasloh or GSSS Gokhra or GSSS Badhu, Distt. Mandi against vacant post.

**Now therefore**, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathetically and the petitioner i.e. Sh. Sundar Lal, Lecturer (School-New) (English) is hereby transferred from GSSS Kashimblidhar (MND) to GSSS Badhu (MND) against vacancy in condonation of short stay & without TTA/JT.

With these observations, representation stands disposed of.
