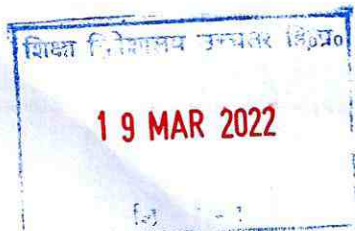



EDN-B-CHHA(5)-1/2018-L-1 dated 27-12-2021 regarding upgradation of **(2 GHSs) (GHS Durah and GHS Kuswah, upto the level of GSSS in Kullu District of the State.** These schools are ordered to be **made functional from academic session 2022-2023** subject to the condition that suitable accommodation i.e. (total 14 rooms) for GSSS is available in the upgraded school as per norms, if additional accommodation is required, shall be provided by the local Public to run the upgraded classes.
