



Keeping in view all such adverse and harsh conditions and also giving top most priority to the safety and security of students and employees, it has been decided to reschedule and pre-poned/adjust the monsoon break in Government/Private Schools affiliated to HP Board of School Education for **current session** as follows :-

Lahaul & Spiti District.	Summer Break	17.07.2023 to 27.08.2023 = 42 Days	10.07.2023 to 20.08.2023 = 42 Days
Kinnaur, Pangi and Bharmour (Tribal Areas)	Monsoon Break	22.07.2023 to 27.07.2023 = 06 Days	10.07.2023 to 15.07.2023 = 06 Days
Other winter closing Schools	Monsoon Break	22.07.2023 to 27.07.2023 = 06 Days	10.07.2023 to 15.07.2023 = 06 Days

Every care has been taken to keep the total number of vacation days the same, so that the teaching days would remain the same.

The Government/Private schools functioning in the State and affiliated to CBSE/ICSE/any other Education Board may take the decision regarding closing of schools at their own level keeping in view their exigencies i.e. ongoing Exams etc. & local weather conditions. It is further advised that safety and security of students and employees be ensured at every level.
