Whereas, Sh. Varinder Kumar, Principal was working at GSSS Chirgaon Distt. Shimla w.e.f. 31.05.2023 and is under order of transfer from GSSS Chirgaon Distt. Shimla to GSSS Jiskun Distt. Shimla vide Notification No.EDN-B-B(6)-24/2023 dated 27.07.2024.


He has submitted a representation seeking cancellation of his transfer or adjustment at GSSS Trilokpur Distt. Sirmour against vacancy keeping in view his adverse family circumstances. He has stated that he was promoted as Principal on placement basis with no financial benefits and posted at GSSS Chirgaon Distt. Shimla on 31.5.2023 which is 260 Kms away from his native place. He is facing many difficulties, giving very few time to take care of his old widowed and ailing mother as his wife is also working at DIET Nahan. He is going to retire within 2 years.

Further, he has stated that he has served in sub cadre area of District Kullu and his ill health and family conditions do not allow him to work in hard area in this age. Therefore, he has requested to cancel his transfer orders or he may be transferred to GSSS Trilokpur Distt. Sirmour against vacancy from where he can look after his family also. He has also stated that he has been transferred without the knowledge of SMC, without his consent and without TTA/JT.

Further, as per the information gathered from his service record, he remained posted at the following stations i.e. GSSS Basdehra Distt. Una (from:04.12.1989 to 12.07.2000), GSSS Banjar Distt. Kullu (from:17.07.2000 to 22.05.2007), GSSS Nahan Distt. Sirmour (from:11.09.2007 to 01.01.2020), DDHE Solan (from:24.01.2020 to 29.05.2023), GSSS Chirgaon (from:31.05.2023 to till date). He remained posted in his home District for a long period of about 13 years.

Whereas, the State Government has imposed complete ban on transfers in Education Department from 31.07.2024. The incumbent Sh. Varinder Kumar, Principal has been transferred to a school against vacancy with prior approval of the competent authority. The post of Principal (School) is a Class-I post and the State Govt. can post him anywhere in the State as per the provision 10 of "Comprehensive Guiding Principles-2013" for regulating

the transfer of State Government employees. Thus, he cannot be adjusted at some other place at this point of time. Therefore, his representation is rejected and he is directed to join at GSSS Jiskun Distt. Shimla with TTA/JT against vacancy.


