In this context, all the Heads Government Educational Institutions (within and outside of Himachal Pradesh where Himachali bonafide students are studying and who are claiming scholarship from the State Government) are requested to ensure the following:-

1. The last date for the registration of students under various Centrally & State Sponsored Scholarship

Schemes has been extended upto 03-03-2023.

The Head of the Educational Institution and Nodal Officer of the concerned Educational Institution will ensure to check their Scholarship Login ID on hourly basis and daily basis for the verification of defective scholarship applications and all scholarship applications must be verified or defected on or before 07-03-2023, positively.

3. As per procedure to apply for scholarship under various Centre and State Sponsored Post-Matric Scholarship Schemes, only complete scholarship applications in all respect after checking the eligibility credentials such as self attested Caste Certificate, Income Certificate of the Parents, Bonafide / Domicile Certificate, Latest Mark-sheets of previous year certificates/ diploma/ degree, gap year, etc. (as the case may be) must be pushed to State Login ID on National Scholarship Portal within prescribed timeline. Incomplete scholarship applications must not be verified and pushed to State Login ID and such scholarship applications may be reverted back to the students login Id.

The Ministry of Social Justice and Empowerment, Government of India, New Delhi, has allowed last chance to students for the registration and verification of scholarship applications. After this

date, further no extension will be allowed.
