**OFFICE ORDER**

Whereas, Sh. Vijay Singh, DPE who is under orders of transfer from GSSS Bahali (Shimla) to GSSS Khamadi (Shimla) and further adjusted at GSSS Darkali (Shimla) vice Sh. Narender Dutt Sharma, DPE vide this office order dated 20.07.2024, Sh. Narender Dutt Sharma, DPE has filed CWP No.7168/2024 before the Hon'ble High Court against this transfer orders.

The case was listed before Hon'ble High Court on 24.07.2024 when the case was disposed of with the following directions:-

**"In view of the aforesaid facts and attending circumstances, the petitioner is permitted to make a representation to the concerned quarters for seeking a transfer to a soft station i.e. station of choice of the petitioner. The said representation be made within the three days from today. The same be decided within the two weeks i.e. on or before 8 august 2024 till than the impugned transfer order in so far as it pertains to the petitioner i.e. office orders dated 20.07.2024 shall remain stayed".**

And whereas, upon passing of above directions, petitioner has submitted his representation on dated 30.07.2024 vide which he has requested to adjust him at the choice of stations i.e. GSSS Masli,/GSSS Dhamwari/ GSSS Kaloti (Shimla)/GSSS Rohru/GSSS Dalgaon Distt. Shimla.

And whereas, as per direction passed by the Hon'ble High Court as above, the request of petitioner has been considered and found that at present the post of DPE is not lying vacant at above mentioned schools and incumbents presently posted in these stations having short stay at present place of posting.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected and his transfer orders dated 20.07.2024 shall stand.

With these observations, representation stands disposed of
