## ORDER

All schools shall continue to remain close, except residential schools further up to 14.09.2021. Teaching and non-teaching staff shall continue to attend the school. For residential schools SOPs developed by the Department of Education will be followed to contain the spread of COVID-19.

## Penal Provisions:

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

This order will come into effect immediately and shall remain in force till further order and all other restrictions and relaxations shall remain same as per previous SEC orders.
