ORDER

Whereas, Smt. Yashoda Devi, Lecturer (School-New) (Sociology) was transferred from GSSS Kuftu (SLN) to GSSS Beolia (SML) against vacancy being caused due to retirement of present incumbent on 30.04.2023 vide office order dated 21.04.2023. But later on transfer orders were cancelled and transfer orders in r/o Smt. Veena Kumari, Lecturer (School-New) Sociology from GBSSS Kunihar (SLN) to GSSS Beolia (SML) were issued vide office order dated 27.04.2023. Thereafter these orders were again modified and Smt. Veena Kumari, Lecturer (School-New) Sociology) who is u/t from GBSSS Kunihar (SLN) to GSSS Beolia (SML) adjusted at GSSS Sanjauli (SML) vice Sh. Kalyan Singh Jhouta, Lecturer (School-New) Sociology and he further transferred to GSSS Beolia (SML) vide office order dated 28.04.2023. Against the cancellation order dated 27.04.2023 Smt. Yashoda Devi, filed CWP No. 2483/2023 before the Hon'ble Court. The case was finally listed before the Hon'ble Court on 15.05.2023 when the case was disposed of with the following directions:-

"Petitioner is permitted and directed to submit a detailed representation for redressal of her grievances on or before 19.05.2023 to respondent No. 2 Director, Higher Education, Himachal Pradesh, within two days, i.e. on or before 28th April 2023 and in case, such representation is preferred, the same shall be decided by respondent No.2 sympathetically on or before 31.05.2023, by passing an appropriate and speaking and reasoned order in accordance with Rules, Policy and law as applicable."

And whereas, upon passing of above directions, petitioner, Smt. Yashoda Devi, Lecturer (School-New) (Sociology) submitted a representation and requested to adjust her in and around Shimla town against vacancy or longer stay keeping in view her ailment as well as couple case.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Lecturer (Sociology) is not lying vacant in and around Shimla town and there is no longer in stay in and around Shimla town.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.
