Based on the Ministry of Education vide D.O. letter number F.16-5/2020-TEL dated 29.05.2026, HEIs are informed that all credit awarding institutions are required to upload **academic records, including marksheets/grade sheets and corresponding credit data, pertaining to the Examination Year 2025 on the NAD/ABC platform by 30th June 2026.** The above timeline shall be treated as final for uploading academic records relating to Examination Year 2025. After the deadline, the upload window will be closed, and no further fresh uploads for Examination Year 2025 shall be permitted on the platform. However, corrections or modifications to already uploaded records may be permitted only in exceptional cases and in accordance with the prescribed procedures of the NAD/ABC system.
