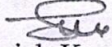
Whereas, the petitioners & non-petitioners were appointed in the Department as Clerks/JOA (IT) on contract basis and were paid contract emoluments as applicable at that time as per instructions issued by Finance Department from time to time. Subsequently, they were regularized as per approval conveyed by the Government from time to time. Now, they have filed various cases in CWP No. 1197/2026 Ghandharva Kumar Vs State of HP, CWP No. 11736/2025 Bhushan Joshi & others Vs State of HP, CWP No. 17025/2025 Neeraj Kumar Vs State of HP, CWP No. 17027/2025 Dinesh Kumar Vs State of HP, CWP No. 16948/2025 Jagan Nath Vs State of HP, CWP No. 20214/2025 Tek Chand & others Vs State of HP, CWP No. 20995/2025 Jagmohan Singh Vs State of HP, CWP No. 20348/2025 Praveen Kumar & others Vs State of HP, CWP No. 892/2026 Sanjeev Kumar & others Vs State of HP, CWP No. 914/2026 Vipin Sharma & others Vs State of HP, CWP No. 2404/2026 Meera Devi & others Vs State of HP, CWP No. 2572/2026 Javed Ali & others Vs State of HP, CWP No. 2401/2026 Neelam Thakur & others Vs State of HP, CWP No. 2402/2026 Sudesh Kumari & others Vs State of HP, CWP No. 2403 of 2026 titled as Kalpana Thakur and others vs. State of HP, and others, CWP No. 575/2026 Ashutosh Negi & others Vs State of HP, CWP No. 2540/2026 Mohit Sharma & others Vs State of HP, CWP No. 2377/2026 Ashok Chauhan & others Vs State of HP and CWP No. 573/2026 Kabir Singh & others Vs State of HP which were disposed of with the direction to consider and decide the case/judgment on the analogy of the cases of Sh. Yashwant Kumar and Sh. Ghanshyam Dass, and also to consider the representations submitted by the petitioners, in accordance with law.

And whereas, the judgment passed in the case of Ghanshyam Dass in COPC No. 722/2024 in CWP No. 2056 of 2023 has been challenged by filing an LPA before the Hon'ble High Court, which has been registered and is still pending adjudication.

And whereas, as per the directions conveyed by the Government vide letter No. EDUA-B015/4/2023-EDU-A/122834 dated 11.05.2026, *the Health Department has already filed an LPA in the main connected case, i.e. CWP No. 8148 of 2022 titled Yashwant Kumar & others vs. State. Further, in another similar matter, i.e., COPC No. 713/2024 in CWP No. 4711/2023 titled Rishabh Chambial & others vs. State, approval for filing LPA has already been conveyed.*

Now, therefore, in view of the facts and circumstances of the case and since the judgment passed by the Hon'ble High Court in CWP No. 2056 of 2023 titled as Ghanshyam Dass Vs. State of H.P. & ors has been challenged by filing an LPA before the Hon'ble High Court, which is still pending adjudication. Therefore, the claim of revised emoluments for the contract period cannot be granted to the petitioners /non-petitioners till final outcome of LPA.

May inform the parties accordingly.
